**1. Title of the Practice:** Creating a Student Centric and advanced Teaching and Learning Environment

## 2. Objectives of the Practice

- 5. Organizing skill development activities and programs. The College has designed seven skill development courses. University approved these courses and make them part of syllabus.
- 6. To provide the proper practical knowledge to the students, MoU were signed in different courses with suitable agency/Institute/Industry.

### 5. Evidences of success:

Many students are getting benefited by the e-contents developed by our teachers. Digital tools and techniques were used by almost all of the teachers during the session. Developed skill courses are smoothly running, and students are getting benefitted. Various short term skill certificates, courses are also smoothly running.
